

Ordinance No R-25/2017
of the Rector of Lublin University of Technology
of 28 June 2017

on the amounts of payments for accommodation in Student Dormitories at Lublin University
of Technology and rules of payment reductions

Pursuant to Article 66 of the Act of 27 July 2005 Law on Higher Education
(Journal of Laws of 2016 item 1842, as amended) it is hereby ordered as follows:

§ 1

1. In the period between 1 July 2017 and 30 June 2018, the following price list for accommodation in Student Dormitories is introduced:
 - 1) LUT's students and doctoral students:
 - a place in a triple room 345.00 PLN/month
 - a place in a double room 440.00 PLN/month
 - a place in a single room 850.00 PLN/month
 - 2) Students from universities in Lublin included in the Agreement on accommodation of students and doctoral students, concluded on 17 February 2011:
 - a place in a triple room 370.00 PLN/month
 - a place in a double room 470.00 PLN/month
 - a place in a single room 950.00 PLN/month
 - 3) ERASMUS PLUS, other international educational programs and Bilateral Agreements students:
 - a place in a triple room 410.00 PLN/month
 - a place in a double room 490.00 PLN/month
 - a place in a single room 1 000.00 PLN/month
 - 4) Other persons who have been granted a place in Students' Halls of Residence for academic year:
 - a place in a triple room 370.00 PLN/month+8% tax – 399.60 PLN/month
 - a place in a double room 470.00 PLN/month+8% tax- 507.60 PLN/month
 - a place in a single room 950.00 PLN/month+8% tax- 1 026.00 PLN/month
 - 5) Guests visiting students living in dormitories, staying in their rooms:

- LUT'S students 20.00 PLN/day,
 - Other people 20.00 PLN/day+8% tax – 21.60 PLN/day/person
- 6) Accommodation in a guest room (Dormitory No. 2 and 4, rooms No. 101, 102, 103):
- place - 100.00 PLN/day+8% tax – 108.00 PLN/day,
- 7) Accommodation in a guest room (Dormitory No. 2, rooms No. 4, 5, 6, 7):
- place - 60.00 PLN/day+8% tax – 64.80 PLN/day,
2. Accommodation on the conditions other than the conditions specified in par. 1, accommodation for one day or longer, the following rules apply:
- 1) Intramural students and doctoral students of Lublin University of Technology – 30.00 PLN/day;
 - 2) Extramural students and doctoral students and other persons:
 - Up to 14 days - 50.00 PLN/day+8% tax – 54.00 PLN/day
 - 15 days and more - 35.00 PLN/day+8% tax – 37.80 PLN/day

§2.

1. Students specified in par. §1.par.1, pt. 1-3 are given a priority in the accommodation procedure.
2. It is possible to be accommodated alone in a double room or in a single room, if the Halls of Residence have rooms available.
3. If the students want to leave the dormitory earlier, the following rule applies:
 1. Before the 15th day of the month, students are obliged to pay half of the monthly rate;
 2. From the 16th day of the month, students are obliged to pay full rate.
 4. In case of ERASMUS PLUS, other international educational programs and Bilateral Agreements students, the rates specified in §1 par 1 p. 3 are obligatory for the period specified in the issued Letter of Acceptance or Invitation, taking into account the fact that:
 - 1) Up to 14 days, students are obliged to pay half of the monthly rate
 - 2) Over 15 days, students are obliged to pay full rate

§3.

1. People staying in the Halls of Residence are entered into the Registration Book kept by the Administrator of the Halls of Residence.
2. In order to be entered into the Registration Book mentioned in par 1, one needs to present the ID Card and confirmation of payment.

§4.

1. The Head of the University Students' Union and the Head of the Students' Union Faculty Council can apply for accommodation in a single room (7 rooms available) – 368.50 PLN/month.

2. Students who are members of the Students' Union, indicated by the Head of the University Students' Union, and the Head of the Students' Union Faculty Council can apply for accommodation in a double room (8 rooms available) – 345.00 PLN/month.

§5.

The regulation comes into force on 1 July 2017.
